***A message from Susanna Lachs Adler, Board Chair, Jewish Federation of Greater Philadelphia:***

Dear Friends,

We hope this finds you, your leadership, staff and families coping as well as can be expected under the emergency conditions presented by the COVID-19 Coronavirus pandemic. The Jewish Federation of Greater Philadelphia is committed to providing essential resources during this crisis. We are coordinating with organizations, schools, synagogues and agencies in the region to assess and assist the most vulnerable individuals in our community whose needs are not being fully addressed by federal, state or local public emergency funds or loans.

This week we launched the [COVID-19 Emergency Response Fund](#) for the collective benefit of all our synagogue and agency partners, grantees, and stakeholders. One hundred percent of the funds raised through this effort will go directly to pay for needs created by the COVID-19 pandemic.

Jewish Federation professionals are working with you, our clergy, and your staff, to obtain data on immediate hard costs, with the knowledge that these will change and increase over time. We have created a nimble process, led by our Crisis Management Committee, and will be making allocation decisions both quickly and efficiently. Together, with your help, we will serve our most vital role as the collective voice of the community.

We realize there is no normal at this time and, consistent with CDC and Department of Public Health guidelines, we are recruiting and safely enlisting volunteers to perform critical tasks on behalf of those who are unable to leave their homes. We are convening volunteers who will assist us and each of you with these efforts. As the central address for Jewish life in Greater Philadelphia, your Jewish Federation is able to diligently coordinate this effort.

While we are all aware of the volatility that COVID-19 is creating in the financial markets, the dire needs of the community and those most at risk remain paramount. We are asking for your assistance in this work.
